Jeana is Associate Professor of Professional Practice in the Management & Global Business Department, Rutgers Business School, and Executive Director of the [Rutgers Institute for Corporate Social Innovation \(RICSI\)](#). She leads the UN [Principles for Responsible Management Education \(PRME\)](#) initiative and teaches Sustainability/ESG related courses in Rutgers Business School's MBA and Executive Education.

Jeana is the lead editor and author of [The Sustainable Enterprise Fieldbook: Building New Bridges](#) (Greenleaf, 2008; Routledge, 2019). Her previous book: [Building a Culture for Sustainability: People, Planet and Profits in a New Green Economy](#) (Praeger, 2014) shows how to holistically integrate sustainability throughout the culture of organizations. She is also the CEO of [Transitioning to Green](#), a consulting firm for integrating sustainability into business practices.

Previously, Jeana was HR Director at Public Service Enterprise Group and held leadership roles at AT&T. She started her career as a Social Science Analyst in the Federal government where she was a Social Science Analyst in the Office of Research at the U.S. Commission on Civil Rights, and led the Women's Research/Social Processes team at the National Institute of Education.

Jeana holds a Master's degree and Ph.D. in Psychology from UCLA and teaches Organizational Behavior, Corporate Social Innovation, Women Leading in Business, and other management courses at Rutgers Business School.

Tobias A. Fox is the Founder and Managing Director of **Newark Science and Sustainability, Inc.**, a nonprofit organization, and the Newark Community Food System. Fox is also a writer with a decade of independent publishing experience, a professional organizer, agriculturalist, visual storyteller, and coordinator of the annual Sustainable Living Empowerment Conference. For over ten years, he has shown collaborative grassroots leadership, passion, and dedication to sustainability and community growth.

Tobias A. Fox conducts community events, presentations, and workshops on sustainable living, and assists local and global urban farmers and gardeners. Recently, his outreach has expanded to the Dominican Republic, Guatemala, the Philippines, and Africa. Fox was honored as one of the **100 People of Newark** for his outstanding contributions during Newark's 350th anniversary, a project produced by the 100 People Foundation in partnership with PSEG Foundation.

Tobias has participated in tree-planting events in low-income neighborhoods with environmental concerns, and he continuously shares his expertise during conferences and forums. Fox's passion stems from personal experiences. Growing up in a household of sixteen with scarce resources, and losing his mother at 16 and younger brother a year later, he was driven to make a difference. These challenges have strengthened his resolve to bring about significant change in his community.

Dean Lei Lei, Ph.D., Rutgers Business School



Dean Lei Lei holds a **Ph.D. in Industrial Engineering** from the University of Wisconsin, with a minor in Computer Sciences. She has supervised numerous Ph.D. students and served as co-guest editor for *Annals of Operations Research*, associate editor of *IIE Transactions*, and *Naval Research Logistics*. Her research focuses on supply chain network design, operations planning, scheduling, and resource allocation optimization.

Dean Lei has over 50 refereed publications – many appeared in leading journals such as *Management Science*, *INFORMS Journal on Computing*, *Interfaces*, *IIE Transactions*, *European Journal of Operations Research*, *Journal of Operational Research Society*, and *Naval Research Logistics*.

She was listed among ROI-NJ Influencers (2021, 2022, 2023), Top 50 NJ Women in Business Influencers (2021), ROI-NJ Influencer-Higher Education (2021), NJ Difference Makers (2020), NJBIZ Top 50 Women in Business (2015, 2023), and the 2023 Distinguished Achievement Award from her alma mater, College of Engineering, University of Wisconsin-Madison. Dean Lei has received multiple best teacher awards at Rutgers Business School and she is the Founding Director of the Rutgers Center for Supply Chain Management and was nominated as the U.S. Professor of the Year (2010). After serving as the founding chair of the Department of Supply Chain Management from 2008-2014, Dean Lei became the Dean of Rutgers Business School (Newark and New Brunswick) in January 2015.

Dr. Robinson is the author of many articles and books on the topics of management, entrepreneurship and workforce diversity.
